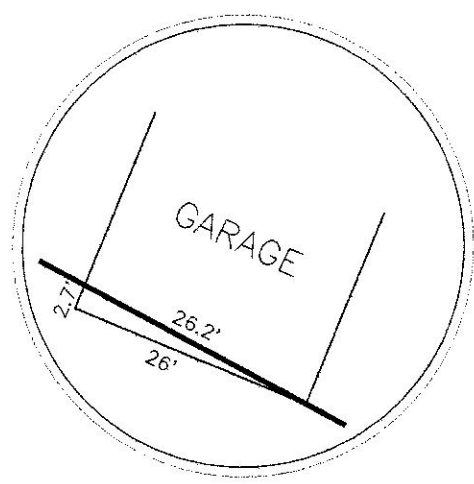
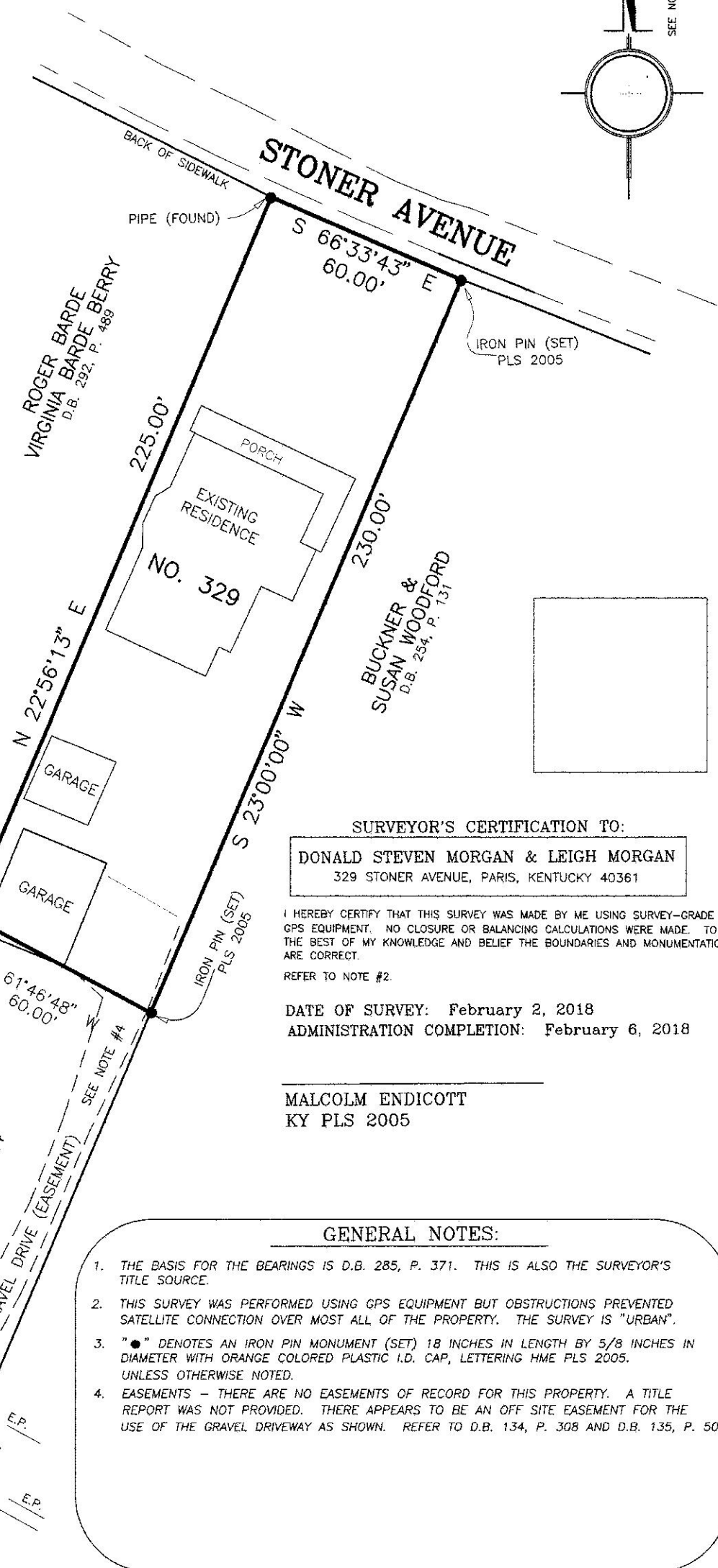


VICINITY MAP
